2 Review of previous year's Actions and outcomes



Minutes:

1. Discussion on Ragging Complaint
 The Principal, Prof. M. Abdul Azees intimated



the meeting following the receipt of a Complaint of ragging via the national helpline. The Complaint was directed to the Convenor to call for an urgent meeting of Anti-ragging cell.

- * The victim's uncle Submitted a written Complaint ~~Signed~~ Signed by the victim leading the Committee to visit the victim immediately

2 Investigation details:

- * The Committee promptly conducted an on-the-spot enquiry and collected Preliminary details including CCTV footages, witness statements from staff and students, and statements from the accused
- * The incident occurred on August 29 2019 around 12:05 PM. It involved Mohammed Fayyad (III Sem BCom CA) and Mohammed Junais VP (V Sem BCom CA) with other Senior Students mentioned in the Complaint
- * The CCTV footage revealed that the victim was accidentally hit during a minor scuffle as students moved between classes and engaged in union election activities. There was no deliberate attack or ragging observed.

3 Recommendations and actions:-

- * The Committee Concluded that the incident did not constitute ragging but was an accidental in it occurring a crowded situation
- * Recommendations include initiating disciplinary



action against Mohammed Junais..VP for pulling and pushing Mohammed Fayyad which led to the accidental push on the victim

- * The Committee decided not to report the matter to the police station but to handle it within the college's disciplinary framework.
- * Additional measures to ensure such incidents do not occur include increased monitoring during high-traffic times and awareness sessions on appropriate conduct.


Actions taken:-

1 Immediate Response:

- * Urgent meeting of Anti-ragging cell convened
- * Victim visited at the hospital and assured of action

2 Investigation:

- * Conducted on-the-spot enquiry and reviewed CCT footage
- * Collected statements from staff students and the accused
- * Identified the incident as an accidental during a minor scuffle



3 Recommendations:-

- * disciplinary action initiated against Mohammed Junais VP for inappropriate conduct.
- * Decision not to involve police, as the incident was accidental

4 Preventive Measures:-

- * Increased monitoring during high-traffic periods
- * Scheduled awareness sessions on Conduct and The importance of maintaining decorum during crowded situations.

5 Follow-up:-

- * Continuous review of anti-ragging measures.
- * Regular meetings to address any emerging issues and ensure a safe campus environment.

Minutes:-

1. Review of the withdrawal request :-

* The Principal Prof: M Abdul Azez initiated the meeting to discuss the withdrawal request



received from Fatima Jabin, the victim of ragging incident reported on 29 August 2019.

- * The letter dated September 7, 2019 expressed Fatima Jabin's wish to withdraw the complaint following an apology from the culprits and their families. They assured that such an incident would not occur.

2 Details of the withdrawal Request:-

- * Fatima Jabin conveyed her gratitude to the Principal and the College authorities for their proactive timely intervention.
- * She mentioned that although the incident had initially upset her, she regained confidence with the support of her family and the College.
- * The culprits and their families apologized, promising that the incident would not be repeated. Consequently, Fatima Jabin decided to withdraw her complaint.

3 Actions and Recommendations:-

- * The Committee acknowledged the receipt of the withdrawal letter and discussed its implications.
- * It was noted that the withdrawal letter would be forwarded to the UGC Anti-Ragging Cell-Delhi as a formal notification of the withdrawal.
- * The Committee decided to close the case officially. Considering the apology and the victim's request.

4 Preventive Measures



- * Despite the withdrawal, the Committee emphasized the importance of continued vigilance to prevent any recurrence such incidents.
- * Plans for increased monitoring during high-traffic periods and additional awareness sessions on appropriate student conduct were reaffirmed.

- Action taken Report -

Incident : Complaint of ragging received on August 29 - 2019 and subsequent withdrawal request by the victim on September 7 - 2019.

1 Immediate Response :-


- * Convened a special meeting of the Anti-Ragging Cell to discuss the withdrawal request.
- * Received the withdrawal letter submitted by Fathima Jabin.

2 Investigation :-

- * Conducted an on the spot enquiry and reviewed CCTV footage and statements.
- * Identified the incident as an accidental push during a minor scuffle.

3 Resolution :-

- * Received and acknowledged the withdrawal request from the victim.
- * Close the case for the victim's withdrawal of complaint.



4 Preventive Measures:

- ★ Continued monitoring and awareness sessions on appropriate student conduct
- ★ Ensure that all actions and communications were formally documented and reported to the UGC Anti-ragging Cell - Delhi



Minutes:-

1 Discussion of the Ragging Complaint

- * The Principal Prof: M. Abdul Azeez initiated the meeting to discuss the Complaint filed by Mohammed Nihal - a second year Bcom CA Student.
- * The Complaint that on November 21 - 2019, Mohammed Nihal was beaten by Mohammed Shabili Taj (Third year Bcom CA Student) and Mohammed Faiz (Former student)

2 Preliminary investigation findings :-

- * The Committee Conducted a preliminary investigation and Collected eyewitness statements.
- * Mohammed Shabili Taj was Summoned, and the complaint was read out to him - He was given until 12 PM to Respond but did not provide any response.
- * Eyewitness Confirmed the incident and the threats made to Mohammed Nihal
- * Mohammed Faiz being a former student could not be Summoned

3 Actions taken:-

- * Mohammed Shabili Taj was Suspended for ten days pending further investigation.
- * The Committee Confirmed the validity of the Complaint based on eyewitness testimonies and the facts and conditions from the first accused.



4 Recommendations :-

- * Suspend Mohammed Shibli Taj for ten days and recommend further disciplinary action.
- * Inform Mohammed Nihal of his right to lodge a private complaint against Mohammed Faiz at the Police Station.
- * Continue monitoring the situation and ensure no further incidents occur.

Action Taken Report

Action taken :-

1 Immediate Response

- * Convened a special meeting of the Anti-Sabotaging Cell on November 22 - 2019.
- * Summoned and questioned Mohammed Shibli Taj, who failed to respond within the given time frame.
- * Collected eyewitness statements confirming the incident.

2 Suspension :-

- * Issued a ten-day suspension notice to Mohammed Shibli Taj, effective immediately.
- * Due to his removal from the college 2011, Mohammed Faiz could not be subjected to college-level disciplinary action.

3 Recommendations :-

- * Proceed with further disciplinary action against Shibli Taj.
- * Advise Mohammed Nihal to lodge a private complaint against Mohammed Faiz at the Police Station.
- * Ensure continuous monitoring of the situation.

- * The Convenor reported that minor verbal clashes has been resolved through mediation and did not escalate into ragging incidents.

2 Evaluation of Action taken

- * The awareness programme for Freshers and their Parents during the Orientation Session was effective.
- * Workshops and Seminars were well-attended with positive feed back from participants.
- * Regular monitoring and increased Vigilance prevented any major incidents.
- * helpline number was effective, though there were fewer calls compared to the previous year.
- * Posters and banners continued to serve a ~~date~~ deterrent against ragging.

3 Patrol Report

- * Patrols were carried out routinely, with special attention to first year Student areas.
- * No serious incidents were reported and minor conflicts were quickly resolved.
- * The presence of patrols contributed to a sense of security among students.

Suggestions for the next Academic year

- * Increase interactive components in workshops to engage students more effectively.
- * Implement a mentor ship programme where Students guide freshers fostering a Supportive environment.
- * Conduct Surprise inspections in hostels across all student categories.
