Sub:- Investigation details of Anti-Ragging Committee held on 30-08-2019- regarding;

Ref:- ARCC/KL-5741

Refer ARCC/KL5741 E mail received on a complaint of ragging from national help-line on anti-ragging. In the event of receipt of information of ragging mentioned above, the chairman of the committee directed the convenor to convene an urgent meeting of the Anti-ragging committee. The committee meeting was held at 10 AM on 30th August. While the meeting was in progress the said victim's uncle submitted a typewritten complaint signed by the victim to the chairman of the committee. The committee resolved to visit the victim immediately and six members of the committee visited the victim at the hospital. The committee members interacted with the victim, counselled her and assured her that action will be taken on her complaint. The committee drew information from the victim on the incident and she stated the details of the incident before the members the committee.

i) Details of Investigation

Thus the Anti-Ragging Committee promptly conducted the preliminary on the spot enquiry and collected details of the incident as available prima facie. The CCTV footage of the incident, eye witness statements of the staff members, students and statements of the accused were also taken. The incident occurred on August 29th 2019, at around 12.05 am at a time when the third hour classes are to be started. It was a time when the students were shifting from the language classes to their concerned classes. More over the candidates who filed nominations for college student union election were busily engaged on the corridors to finalise their candidature. There was hectic movements of a students on the corridors and on the stairways regarding withdrawals of candidature and finalisation. There were differences of opinions among students on this and it resulted in exchanges of words and minor dispute with a second year students namely Mohammed Fayyad (IIIrd Sem B.Com CA) and Mohammed Junais VP (Vth Sem B.Com CA), the First accused. Mohammed Fayyad (IIIrd Sem B.Com CA) was pulled and Beaten once by Mohammed Junais VP (Vth Sem B.Com CA) and then he was pushed aside. He got hit with the second year student Fathima Jubin's back accidentally and Fathima Jubin TK (IIIrd Sem BA Economics) staggered for a while. (Evident in the CCTV visuals) She was a passing through the staircase at that time. That sudden hit gave her much pain and felt harassed. She immediately brought this matter to the vice principal. The vice principal advised her to the ladies room for a short rest and after while the office assistant was sent to call the victim and directed her to go to the hospital with the staff members. The staff members took her to hospital with a friend accompanying her.

The committee reviewed the pre and post incident video footages also to identify the nature of the incident. The committee also reviewed the statements of the eyewitness staff members, students and the accused. The preliminary investigation/details of the incident was immediately brought to the notice of the committee. The report and recommendations are considered by the Anti-Ragging Committee for deciding the actions and punishments on the erring students in terms of provisions contained at Clause 9.1 of the UGC regulations.

ii) **Reports of Investigation**

In the petition given by the victim she stated that she was manhandled and ragged by a group of final year boys namely Mohammed Junais VP (Vth Sem B.Com CA), Mahroof Ottupurath (Vth Sem BA Political Science), Ashique Yunus CP (Vth Sem B.Com Finance), Ismayil CP (Vth Sem B.Com CA), Mohammed Nabeel NK (Vth Sem B.Com CA), Muhammed Yazin NM (Vth Sem BBA), Muhamed Muqtar PT (Vth Sem BA Political Science) and some others who can be better identified by CCTV footage. While reviewing the CCTV footage such an incident purposefully directed towards the victim was not seen in the visuals. She was neither manhandled, ragged or abused but she was hurt while a minor scuffle occurred on the staircase and thereby she was pushed aside on her back by a second year student who were beaten and pulled by Mohammed Junais VP (Vth Sem B.Com CA), the first accused. These students were returning after the withdrawal of the nominations for the student union elections and more over the students were shifting from one classroom to another during language hours. It is evident from the CCTV footage that the push inflicted on Fayyad and his body accidentally hit on the back of Fathima Jubin. These senior students did not harass her physically and mentally. And moreover the blow and the push received by Mohammed Fayyad (IIIrd Sem B.Com CA) which is evident in the video footage were not reported as a conflict by Mohammed Fayyad (IIIrd Sem B.Com CA). It's further observed from the CCTV footage that no disorderly conduct whether by words spoken or by an act of manhandling with rudeness causing injury to the victim deliberately. And further during the interaction with the victim though she filed a written complaint sited above she admitted before the Anti Ragging Committee that she got an accidental push on her back which gave her much pain and agony. And finally in the CCTV footage the first accused Mohammed Junais VP (Vth Sem B.Com CA) was pulling and pushing Mohammed Fayyad (IIIrd Sem B.Com CA) while others were either standing or passing through the staircase. Ismail, the fourth accused and Mukthar, the seventh accused was not found in CCTV footage. All these factors corroborate that there is no purposeful evidence of attack, ragging or abuse towards the complainant.

iv) **Recommendations:**

The ARC investigated the matter, interacted with the victim summoned the accused, received the statements of the teaching staff and examined the CCTV footage for one hour. All these clearly evidence that there is no proof to support that the victim was manhandled and abused by the accused. But she was hurt accidentally in the minor scuffle that was triggered after the withdrawal of nominations for the union elections. The ARC concludes that there is no element of ragging involved and therefore it is not pertinent to report the matter to the police and to proceed with the filing of a FIR within 24 hours of the receipt of such information.

For the violation of the college rules, student code of conduct separate disciplinary proceedings may be forthwith initiated by the college discipline committee against the gross misbehaviour shown by Mohammed Junais VP (Vth Sem B.Com CA) the first accused for pulling, pushing and beating Mohammed Junais VP (Vth Sem B.Com CA) which perpetuated ultimately into the unhappy incidence. The rest of the accused have no direct involvement and participation in any complaints filed by the complainant and therefore, no disciplinary actions are required.

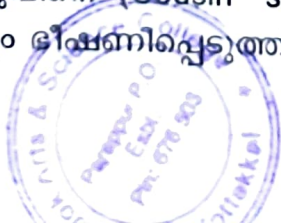

21.11.2019 നു മേൽ കോളേജിലെ പാർക്കിംഗ് സ്ഥലത്തു വെച്ച് ഉച്ചഭക്ഷണത്തിനു കോളേജ് വിട്ട സമയത്ത് തന്റെ പാർക്ക് ചെയ്ത ഇരുചക്ര വാഹനമെടുക്കാൻ ചെന്ന രണ്ടാം വർഷ ബി.കോം CA വിദ്യാർത്ഥി മുഹമ്മദ് നിഹാൽ എന്നയാളെ ഈ കോളേജിൽ തന്നെ പഠിക്കുന്ന മൂന്നാം വർഷ ബി.കോം CA വിദ്യാർത്ഥി മുഹമ്മദ് ഷിബിലി താജും മതിയായ ഹാജരില്ലാത്ത കാരണത്താൽ കോളേജ് പട്ടികയിൽ നിന്ന് നീക്കം ചെയ്യപ്പെട്ട മുഹമ്മദ് ഫായിസ് എന്ന പൂർവ്വ വിദ്യാർത്ഥിയും കൂടി മർദ്ദിച്ചതായി പരാതി ലഭിച്ചിരിക്കുന്നു. പരാതി പ്രകാരം ആരോപിതരായ രണ്ടു പേരും നേരത്തെ പലവട്ടം പരാതിക്കാരനോട് താടി വടിച്ചു വരാൻ ആവശ്യപ്പെട്ടിരുന്നു. അന്നേ ദിവസം വാഹനമെടുക്കാൻ ചെന്നനേരം എന്താണ് താടി വടിക്കാൻ പറഞ്ഞിട്ടും വടിക്കാത്തതെന്ന് പറഞ്ഞ് തലക്കും പുറത്തും ശക്തിയായി അടിക്കുകയും നിലത്തു വീണിട്ടും തുടർന്നും ക്രൂരമായി മർദ്ദിക്കുകയും ചെയ്തു. ഈ മർദ്ദന ശേഷം പ്രിൻസിപ്പാളിനോട് പരാതിപ്പെടാൻ പോകുമ്പോൾ പരാതിയുമായി മുന്നോട്ട് പോയാൽ കടുത്ത പ്രത്യാഘാതങ്ങൾ നേരിടേണ്ടി വരുമെന്നും കോളേജിൽ തുടർന്നു പഠിക്കാൻ സമ്മതിക്കില്ലെന്നും ഭീഷണിപ്പെടുത്തി. കൂടാതെ ഒന്നാം കുറ്റാരോപിതന്റെ ജൂനിയർ ബന്ധുവിനെ (Cousin sister) ഉപയോഗിച്ച് വ്യാജ റാഗിംഗ് പരാതി കൊടുക്കുമെന്നും ഭീഷണിപ്പെടുത്തി.




പരാതി ലഭിച്ചതിന്റെ പിറ്റേ പ്രവൃത്തിദിവസം ആന്റീ റാഗിംഗി കമ്മറ്റി ചേരുകയും പ്രാഥമികാനേഷണങ്ങൾ നടത്തുകയും ചെയ്തു. ഒന്നാം കുറ്റാരോപിതനായ മുഹമ്മദ് ഷിബിലി താജിനെ കമ്മറ്റി മുമ്പാകെ വിളിച്ചു വരുത്തി പരാതി വായിച്ചു കേൾപ്പിച്ചു. വല്ലതും ബോധിപ്പിക്കാനുണ്ടെങ്കിൽ അന്നുതന്നെ 12 മണിക്കൂ മുമ്പായി ബോധിപ്പിക്കണമെന്നും ഇല്ലെങ്കിൽ പരാതിയിൽ എഴുതിയത് സത്യ വിരുദ്ധമല്ലെന്ന് കണ്ടെത്തി തുടർ നടപടികളുമായി മുന്നോട്ടു പോകുമെന്നും രേഖാമൂലം അറിയിച്ചു. ഒന്നാം കുറ്റാരോപിതനെ പത്തു ദിവസത്തേക്ക് കൂടുതൽ അന്വേഷണത്തിനും തെളിവെടുപ്പിനുമായി സസ്പെന്റ് ചെയ്തു. രണ്ടാം കുറ്റാരോപിതനായ മുഹമ്മദ് ഫായിസ് എന്നയാളെ കോളേജ് റോളിൽ നിന്ന് 01.06.2018 മുതൽ നീക്കം ചെയ്ത കാരണത്താൽ ആരോപിതനെതിരെ നിയമാനുസൃത നടപടികൾ സ്വീകരിക്കാൻ സാധ്യമല്ലാത്ത കാരണത്താൽ അവനെ വിളിച്ചു വരുത്താനോ മൊഴിയെടുക്കാനോ സാധിച്ചില്ല.

മുഹമ്മദ് നിഹാൽ എന്ന പരാതിക്കാരനെ റാഗ് ചെയ്യുന്നതും മർദ്ദിക്കുന്നതും കണ്ടു നിന്ന ദൃക്സാക്ഷികൾ നേരിട്ടു വന്ന് മൊഴി നൽകി. സംഭവം കണ്ട ദൃക്സാക്ഷികളായവർ വിസ്താര മധ്യേ കുറ്റാരോപിതർ ഭീഷണിപ്പെടുത്തുന്നതായും അറിയിച്ചു.

മേൽ പരാതിയും സാക്ഷി മൊഴികളും പരിശോധിച്ച് കോളേജ് ആന്റീ റാഗിംഗ് കമ്മറ്റി കണ്ടെത്തിയ നിഗമനങ്ങളും ശുപാർശകളും താഴെ ചേർക്കുന്നു.

1. നേരത്തെ ഒന്നാം കുറ്റാരോപിതന് സസ്പെൻഷൻ നോട്ടീസ് നൽകി വല്ലതും ബോധിപ്പിക്കാനുണ്ടെങ്കിൽ അന്നു തന്നെ മറുപടി ആവശ്യപ്പെട്ടിരുന്നു എന്നാൽ പറഞ്ഞ സമയത്തിനകം മറുപടി തരാത്തതിനാലും മറ്റ് സാക്ഷികളുടെ മൊഴി പ്രകാരവും പരാതിയിൽ സത്യമുണ്ടെന്നും റാഗിംഗ് പരാതിയിൽ വരുന്ന സംഭവങ്ങൾ ഉണ്ടായിട്ടുണ്ട് എന്നും വരുന്നു.
2. രണ്ടാം കുറ്റാരോപിതൻ നേരത്തെ കോളേജിൽ നിന്ന് നീക്കം ചെയ്യപ്പെട്ട വിദ്യാർത്ഥിയായതിനാൽ ടിയാനെ വിസ്തരിക്കാനോ കോളേജ് തല അച്ചടക്ക നടപടികൾ സ്വീകരിക്കാനോ സാധ്യമല്ല.
3. അക്കാരണത്താൽ രണ്ടാം കുറ്റാരോപിതനെതിരെ പരാതിക്കാരന് സ്വകാര്യ പരാതി പോലീസ് സ്റ്റേഷനിൽ ബോധിപ്പിക്കാവുന്നതാണ്.
4. ഒന്നും രണ്ടും കുറ്റാരോപിതർക്കെതിരെ നിയമ നടപടികളുമായി മുന്നോട്ട് പോകാവുന്നതാണ്.

Though I was totally upset about the incident happened on the day, I regained confidence with the support of my family and people like you.

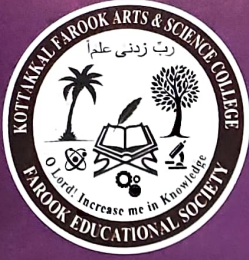

Subject : Complaint regarding ragging/conflict

On 21.11.2019, second year B.Com CA student Muhammad Nihal, third year B.Com CA student studying in the same college, Muhammad Shibili Taj, who went to take his parked two-wheeler from the parking lot of the college while leaving the college for lunch, were removed from the college list due to insufficient attendance. A complaint has also been received that a former student named Muhammad Faiz was also beaten up. According to the complaint, the two accused persons had asked the complainant several times to shave his beard. On that day, when he went to pick up his vehicle, he told him to shave his beard and did not shave it, but he hit him hard on the head and outside and continued to beat him even though he fell to the ground. After this beating, when she went to complain to the principal, she was threatened that if she went ahead with the complaint, she would face severe consequences and would not be allowed to continue studying in the college. He also threatened to use the first accused's junior cousin (Cousin sister) to lodge a false ragging complaint.

The Anti-Ragging Committee met on the next working day after receiving the complaint and conducted preliminary investigations. The first accused Muhammad Shibili Taj was summoned before the committee and the complaint was read out. It was informed in writing that if there is anything to be conveyed, it should be conveyed before 12 o'clock on the same day, otherwise, it will be found that what was written in the complaint is not untrue and further action will be taken. The first accused was suspended for ten days pending further investigation and evidence collection. The second accused Muhammad Faiz was removed from the college roll with effect from 01.06.2018 and could not be called or given a statement as it was not possible to take legal action against the accused.

Eyewitnesses who saw the complainant Muhammad Nihal being ragged and beaten came forward and gave their statement. The eyewitnesses who saw the incident also informed that they were threatening to investigate. The accused

Following are the conclusions and recommendations made by the College Anti-Ragging Committee after examining the above complaint and witness statements.

1. Earlier, the first accused was given a suspension notice and asked if there is anything to explain, but because Vai did not reply within time, and according to the testimony of other witnesses, the complaint is true and there have been incidents of ragging.

2. Since the second accused is a student who has already been expelled from the college, it is not possible to investigate the tian or take college level disciplinary action. 3. For that reason For the complainant against the accused

A private complaint can be lodged at the police station. 4. Legal action can be taken against the first and second accused.
